## APPROVAL OF MINUTES

Approval of Minutes from August 8, 2022, Board Meeting

Speaker: Tom Linza from Sangre de Cristo - Electric update as it pertains to the common areas and final electric shutoff.

Tom Linza met with state inspectors and they looked at the breaker panels on the bathhouses. The Illinois bathhouse is the only one that needs a trench which will be about 40 feet. Regarding the electric conversion, he repeated that there will be no grace periods. Concerning restoring the streets and alleys dug up by Sangre de Cristo, he needs to get a

list of problem areas. The CCOA Manager will send this list to him.

President Joan McCord informed Tom Linza that we needed something in writing stating that after the old pedestals are removed the area where the old pedestal was will be left in good, smooth condition.

Tom Linza stated that letters have been mailed out to property owners who haven't signed up for electric service yet so they can move forward with getting service. If an owner has no intention of using electric service at this time, they can sign up for an account and be charged a "Service Location Retention Fee" of \$84 which will cover July to December. This is a yearly fee that has been prorated for the six months. Contact Sangre de Cristo for details. They will begin to remove the old pedestals on September 6. These old pedestals will be taken away.

If owners are concerned about another person plugging into their pedestal, they can put their own personal lock on the pedestal. If the fire department needs to get to the meter in case of fire, they will be the only ones who can cut it off.

Manager's Report: Colee Kindall, CCOA Manager, gave the following report:

- Joe, our maintenance man, has generously brought his own trailer to Chateau to use for various CCOA work around the park. It will be parked in the garage area.
- Some owners have questioned if they can cut down dead trees on their property. The answer is yes.
- The Mobile Medical Clinic will come monthly to Chateau. An email will go out to all members outlining the services they provide as well as the date of their first visit.
- Some owners have questioned if a popup is allowed on their lot. The answer is yes.
- An electrician will begin work on the bathhouses in order for them to be connected to Sangre de Cristo.
- On Wednesday the stove will be installed in the lodge kitchen.

- 1. Vote to approve the 2023 budget. Motion made by Marilyn, seconded by Pete. No discussion from the board or audience. Passed with 5 yea, 1 nay Kay Jenkins.
- 2. Set agenda for September 3 General Meeting It was decided to have a separate meeting for budget ratification and then immediately afterward have a General Meeting on September 3, 2022. The PowerPoint will cover the new Conduct of Meetings Policy, Compliance, and the 2023 Budget.
